

Privacy Policy

Our goal is to maintain your trust and confidence when handling personal data about you. This Privacy Policy describes how we collect information when you visit or use the [LineGuide Cam](“App” or “Service”) and it also describes how we use and share such information and explains your privacy rights and choices. The terms “we”, “us”, or “our” mean [Peipei Wang]. “You” means an individual who visits our App or uses our Service.

● Use of Personal Data

The reason why we use your personal data is:

- (1) To provide and maintain the App provided to you under the conditions set forth in our Terms or Agreement.
- (2) To manage the security and integrity of the App.
- (3) To communicate with you.
- (4) To improve the App or develop new products, such as to conduct research or to make aggregated and anonymous statistics.
- (5) To reply to your requests to exercise your rights on your personal data.
- (6) To comply with laws.

● Collection of Personal Data

The categories of personal data we collect from you may include the following:

- (1) the type, version, brand, language and operating system of device.
- (2) the type and operator of network (such as Mac address).
- (3) behavioral usage of the App.
- (4) email address.
- (5) device identifiers (such as IDFA, IDFV for Android, GAID for IOS).

● Disclosure of Personal Data

We may disclose the data to the following persons:

- (1) Any related officers, employee, agents, contractors or third party service providers who provides administrative, telecommunications, computing, or other services related to its business operations (e.g. IT vendor or electronic storage vendor).
- (2) Any the group companies.
- (3) Any legal agency, regulatory bodies, government, tax authorities, law enforcement agency, administrative or statutory agency.

● **Personal Data Protection Measures**

We implement protection measures to safeguard and secure your personal data to ensure personal data is protected against unauthorized or accidental access, processing or erasure:

- (1) Access or use of such data is limited to authorized staff or agents in accordance with the principle of “need to know” basis and secured method.
- (2) We distribute the data to other persons only for conducting business activities, complying with applicable laws or protecting against fraud.

● **Retention of Personal Data**

We keep your personal data for as long as necessary to provide you with our Service, for legitimate and essential business purposes, complying with our legal obligations, and resolving disputes. We are committed to protecting the privacy of all personal data processed and aims to ensure that personal data is not kept for longer than is necessary for the purpose for which it was collected, held, and processed.

● **Exercising Your Rights**

We have committed to providing you with means to exercise the following rights:

- (1) the right to ask us for a copy of any personal data that you have provided to us.
- (2) the right to request from us to update, amend, correct, or rectify your

personal data.

- (3) the right to obtain your personal data in a structured, machine-readable format.
- (4) the right to request deletion or destruction of your personal data.
- (5) the right to withdraw your consent.
